

RELEASE AND AGREEMENT NOT TO SUE

In consideration of being allowed to participate in West Yellowstone Rodeo events, I and my heirs, successors, personal representatives and next of kin, hereby RELEASE, WAIVE, DISCHARGE, and agree to HOLD HARMLESS AND INDEMNIFY West Yellowstone Rodeo, the rodeo committee, stock contractor, sponsors, arena operators or owners, their agents, representatives from all liability to me and my personal representatives, heirs, successors, and next of kin from any and all claims and liability for all loss or damage and any claims of damages therefore on account of any injury to my person including death or damage to my property while I am participating in a West Yellowstone Rodeo event.

I hereby represent to West Yellowstone Rodeo that I understand that THERE ARE CERTAIN RISKS OF SERIOUS INJURY AND DEATH inherent in participating in rodeo events and any related activities. I realize conditions of the rodeo arena change from time to time and may become more hazardous, that rodeo animals are dangerous and unpredictable and there is INHERENT DANGER in rodeo which I appreciate and voluntarily assume because I chose to participate in such events. I make this choice even though I have observed or participated in events of this kind in the past and know the conditions, facilities, rodeo animals, and other rodeo contestants and participants pose a danger to me. I recognized and expressly agree to assume the entire risk of any and all accidents or personal injury including serious paralysis or death which I might suffer during participation in said events.

I further COVENANT AND AGREE NO TO SUE West Yellowstone Rodeo for any injury, damages, or death which may occur as a result of my participation in said events and any claim or damage, therefore. I understand that this document may be treated as a complete defense to any legal action I might bring against West Yellowstone Rodeo for any injuries or other damages I might suffer. I understand and agree this RELEASE AND AGREEMENT NOT TO SUE extends to any and all claims I may have, especially including but not limited to, claims arising out of participation in said events, claims with respect to the design, manufacture, repair, or maintenance of the facilities or equipment which I will be using, or with respect to the conditions, certifications, instructions rules or procedures under which my use of said facilities or equipment are conducted or from any other cause.

I UNDERSTAND AND AGREE ON THIS RELEASE AND AGREEMENT NO TO SUE. Extends to ACCIDENT, INJURY OR DEATH OCCURRING DURING THE TERM OF MY PARTICIPATION IN ABOVE MENTIONED EVENTS. Any subsequent releases and agreements I might sign in the future shall amplify, but shall in no way limit, the provisions of the document.

I further state and certify that I have carefully read the foregoing release, know that contents thereof and sign this Release and Agreement Not to Sue as a free and voluntary act. I am not relying on any statements of representation of any party released hereby. I UNDERSTAND THIS A RELEASE OF ALL CLAIMS.
